RE: Data Review Process and Schedule for 2025 Center Outcomes Reporting
DATE: December 1, 2025

Center for International Blood and Marrow Transplant Research (CIBMTR) produces the Center-Specific Survival Analysis annually for all US and select international centers performing allogeneic hematopoietic cell transplantation (alloHCT). The 2026 analysis will include all first alloHCTs performed at US centers during 2022-2024. CIBMTR Clinical Data Analysts are now posting data queries to FormsNet. Centers, please review and correct data as issues are identified. The schedule below outlines the process and timelines.

CIBMTR has a firm deadline of December 31, 2025, for all pre-HCT data collection forms related to the Center-Specific Survival Report. For an in-scope infusion to be included in the analysis, Forms 2400, 2402, 2005, and 2006 must be completed by December 31, 2025. This gives centers one trimester beyond the Continuous Process Improvement expectations to **resolve** any issues, providing centers at least 1 year to complete and correct all pre-HCT information. CIBMTR will accept responses to queries for these patients by March 1, 2026. If pre-HCT data are not complete and error-free for 90% of patients for a center, that center will not be included in the analysis. **As in previous years, all follow-up must be complete by April 30, 2026, for inclusion. For some patients, their 1-year follow-up will need to be completed prior to their CPI deadline.**

Occasionally, center directors request changes to their center's composition, such as merging centers or splitting into distinct adult and pediatric centers and including transplants that have already occurred. CIBMTR will accommodate these requests as they are formally received. **However, only requests made before December 1, 2025, will be incorporated in the 2026 analysis.**

Review pre-transplant raw data file from CIBMTR	Jan. 15, 2026	March 1, 2026
Respond to remaining queries	Nov. 1, 2025	March 1, 2026
Report 1-year survival status	Nov. 1, 2025	April 30, 2026

Note: Patients with pre-HCT Forms in error status and/or corrections made after **March 1, 2026**, will not be included in the analysis.
